- 8. On 04/07/2025 Mr. Kamlesh H. Shah, Administrative of the school appeared before the committee and hearing was conducted. During hearing authorized persons of the school requested to increase at least 20% in fees in each year. After perusing the documents submitted by the school. It appears that the strength of the students is 520 in year 2024-25. It is submitted by the authorized person of the school that school had spent Rs. 92,06,604/- towards salary of the staff, in which, school has produced bank salary certificate issued by HDFC Bank of said amount. The school had suffered a loss of Rs. 1,97,502/-in year 2024-25. School has spent Rs. 36,00,000/- towards rent expense. School
